Intended Purpose

This programme is to cover funding to support a Measles Outbreak from 1 October 2025 until 31 March 2026.

Eligibility:

A person who has been identified by the Public Health team as a Measles case, suspected case or close contact of a measles case (and subsequently is referred to Primary Care) who is in one of the following groups:

- Māori
- Pacific people
- Disabled people
- People with severe mental health and addiction issues
- People living in socioeconomically deprived communities (quintile 4 & 5)
- Other inequitably impacted population groups, including:
 - Migrant ethnic communities
 - Rough sleepers
 - People in transitional housing
 - Those not enrolled in Primary care practices.
- Others as identified as requiring funded support by a Public Health Service

and Public Health have requested the person and or whānau to either:

Attend a primary care provider for a consultation and a PCR swab for measles,

AND/OR

Attend a primary care provider for assessment and administration of an MMR vaccination as post-exposure prophylaxis (PEP) as described in the Immunisation Handbook,

AND/OR

Attend a primary care provider for serology testing for measles,

AND/OR

Attend a primary care provider for a PCR swab for measles (no consultation),

AND/OR

Request a copy of vaccination status for measles (if the provider incurs costs for retrieval of the vaccination record) - Only for New Zealand residents/citizens born between 1969 and 2004 (ie. no NIR/AIR record) OR anyone born overseas without a NIR/AIR record OR those people who opted-off the NIR/AIR record

Claiming

Claiming is via the WellSouth PHN portal.

Communicable Diseases [New Measles Claim](#) Patient must meet eligibility criteria

Claiming is limited to 1 claim per service type, per patient, per day.

Funding is available for both clinical assessment and any review appointments to support the clinical management of an unwell patient.
