Intended Purpose

Long Term Conditions Support - Toitū Takata will allow practices to claim for additional care provided to patients who are living with long term conditions; the focus will be on improving health outcomes, maximising equity and supporting patients to live well.

Eligibility

Eligible patients will meet one (or more) of the following demographic criteria:

- Māori
- Pacific
- Former refugee (quota refugees)
- Community Services Card (CSC) holders
- High Use Health Card holders
- Living in a Q5 area
- Newly diagnosed with a LTC (last 6 months)

And have one (or more) of the following long term conditions:

- Cardiovascular disease
- Respiratory disease
- Diabetes
- Gout
- Stroke
- Any other long term condition; these patients must account for no more than 10% of the total practice allocation of funded spaces on Long Term Conditions Support - Toitū Takata.

Or

• Patients with severe and enduring mental illness or addiction.

Exclusions

• Patients under 14

Key Information

- The minimum expected care for those on Long Term Conditions Support - Toitū Takata is: two practice nurse appointments, one GP or NP appointment and one care plan completed during the year.
- Complete a review for the patient at the end of 12 months, the review will identify the interventions and outcomes that have occurred for the patient while they are on the programme. The review can take place 51-56 weeks following the initial enrolment.
