## Intended Purpose

HPV primary screening will reduce barriers to uptake and increase screening in priority groups to reduce mortality rates in our communities. This programme allows for practices to claim for eligible patients to have a HPV swab or speculum test.

## Eligibility

Patients who are eligible for funded screening are:

- a) Wāhine/women or person with a cervix aged 25 to 69 years who are Māori, Pacific, or CSC (community services card) holders and require a routine screen (MUST BE DUE).
- b) All Wāhine/women and people with a cervix who are unscreened (have never been screened)/ or under-screened (haven't had a cytology test in the past 5 years) aged 30-74 years.
- c) Anyone requiring follow up. Please see overleaf for detailed breakdown of eligibility criteria.

**Claims for non-eligible patients will not be paid— please check before offering a free screen.**

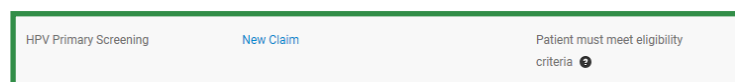

## When does the claim need to be completed?

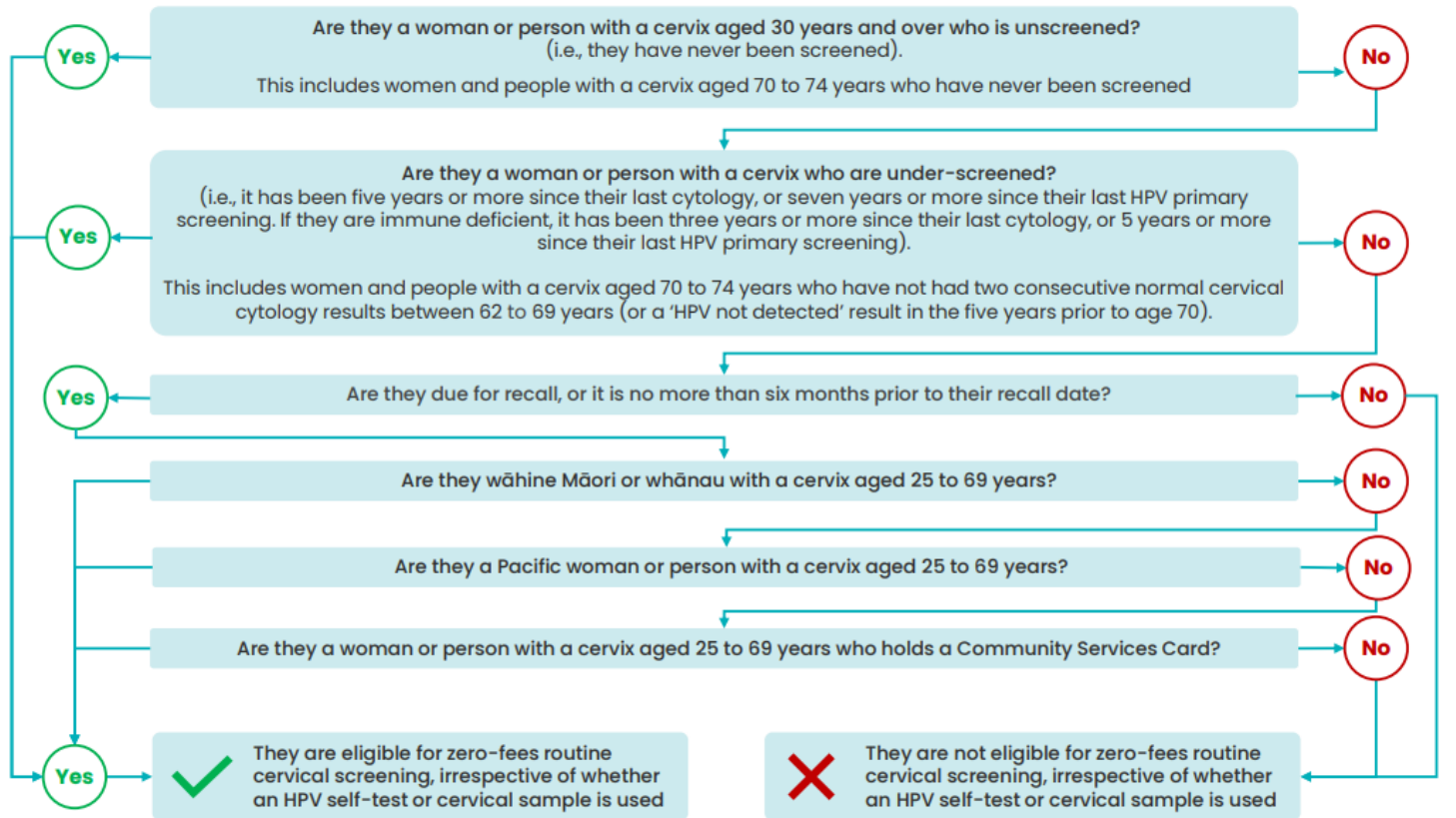
Claiming must be completed within 2 months of treatment.

# Who is Eligible for zero-fees Cervical Screening – 25 years and over?

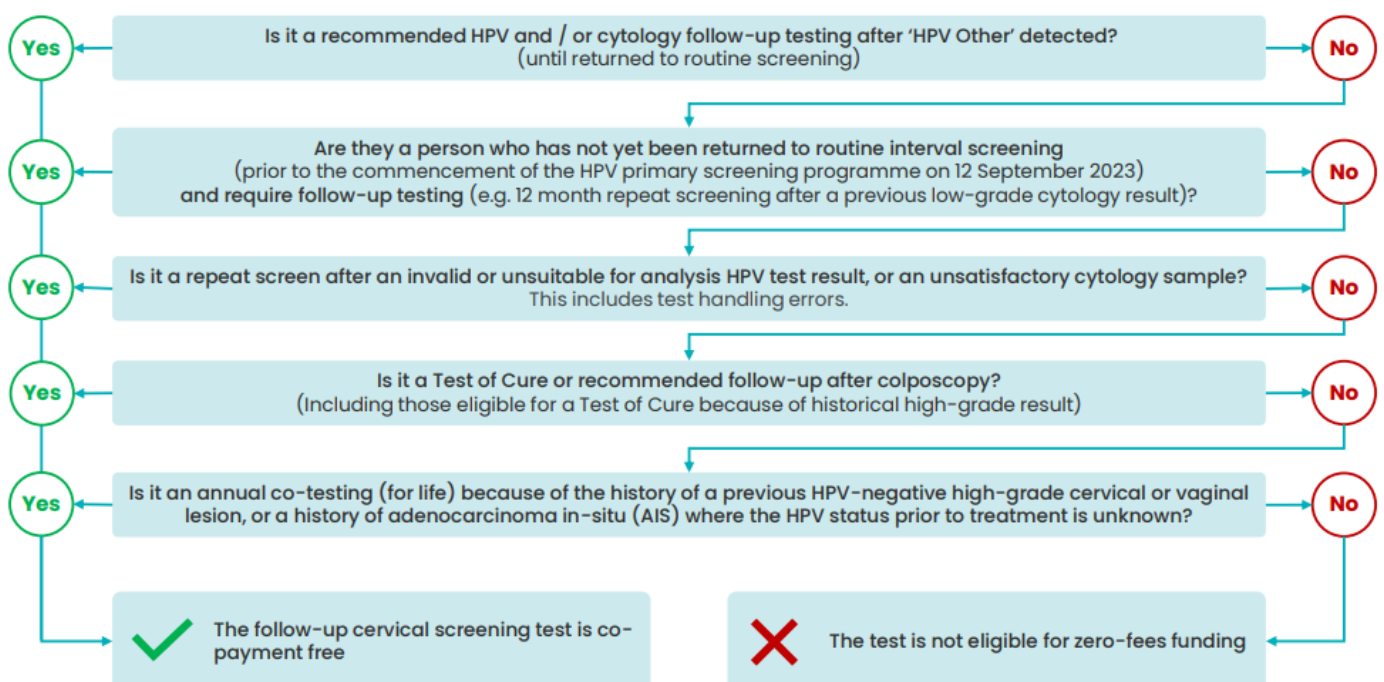
