Intended Purpose

This programme extends the funded Influenza vaccination to include 55-64 year old Māori and Pasifika patients as an additional funded initiative within Southern.

The aim is to ensure a reduction in comorbidity and mortality rates of illness related to Influenza in these priority population groups.

This programme is available to claim through flu season, from 2nd April 2024 until 30th September 2024.

Eligibility

Patient must be:

• Māori aged 55-64

OR

Pasifika aged 55-64

AND

• Not eligible for a funded influenza vaccine

Key Information

- 1. Check patient eligibility for Pharmac funded vaccine
- 2. Submit vaccine administration information via PMS as usual either: Funded Flu

Non-funded Flu

3. If non-funded Flu, submit claim via WellSouth portal (see Claiming)

Exclusions

Any patient who does not meet the above criteria.

N.B. This programme is not for CSC or HUHC holders, or Q5 patients (unless they are Māori/or Pasifika).

Audit

Claims may be subject to Audit at WellSouth discretion.
